Edemia Johnson- (1sr & 6th Grade Parent)

Stated concerns that her child is being bullied by another student in her class. Spoke with TISA Director Richard Greywolf and was not able to arise a plan in order to move forward with the comfort of the safety of her child. Police reports have already been made.

Megan Avina- (1st Grade Parent/4th Grade Teacher)

Stated concerns that her child and herself have been terrorized by another parent of the school. Police reports have been filed in regards to the case. She is concerned that the parent is allowed to communicate with her child on school grounds. She stated how this has all affected her not only as a parent but also as a teacher.

Nicole Kowalski- (1st Grade Teacher)

Stated her primary job is to insure the children's safety while at school. She uses steps to regulate the student's behaviors such as clip chart, self-reflection and "fluff puff" which celebrates kindness throughout the classroom. In this case she felt as though she could have resolved and issues that the students or parent had if they would have brought it to her attention before it escalated to the point where police are involved. She feels as though staff and administration have supported her.

Tracy Bell- (2nd & 4th Grade Parent)

Stated that she is pleased with how she learned to navigate with the help of the teachers her at TISA. Tracy then specified that administration and teachers have always addressed issues and concerns in a helpful prompt way.

Shelli Noble- (2nd Grade/4th Grade Teacher)

Stated she is here to support TISA Staff for always addressing issues as they are presented.

Patsy Kinney- (2nd Grade Teacher)

Stated her experience as a teacher and educator. Explained how TISA is a small intimate school that resolves issues as they arise. Stated that she felt full support from our Director Richard Greywolf and TISA administration.

Doug Bell- (2ng & 4th Grade Parents)

Stated the his support for teachers here at TISA. Our teachers here show compassion and always offer help if needed.

Pam Bishop- (1st Grade Parent)

Stated concerns with her child and another student from last year but has seen improvement in classroom behaviors. She feels as if the teacher and staff have always had open lines if there are any concerns. Met with the 1st grade teacher to address her concerns when school first started and has yet to encounter the behavior the child experienced last year.

Wally Kueshner- (Education Assistant)

Stated her background in Early Childhood Education and observes various children's behaviors, inside as well as outside of the classroom. She stated that she has never felt as if the behaviors of these students required Police attention. To resolve the issues everyone should increase communications with one another and feel comfortable to state concerns. Students should also feel comfortable talking with adults at the school to make appropriate reports.
